I, the undersigned, (must be of legal age [18 years or older] to sign) agree that the Host Club has the right to refuse my entry for causes that the organizing committee shall deem to be sufficient.

**NOTICE TO EXHIBITORS**

There shall be no refunds for entries withdrawn after the closing date or in the event of a dog and/or handler being dismissed from competition, regardless of reason for such dismissal. Refunds will be made for medical reasons (dog or handler) or for bitches in season, with certification from a vet. No bitches in season will be accommodated on the site.

Handlers and dogs should be familiar with AAC equipment. Training will not be allowed. There shall be no food or toys used in the ring at any time. Collars can be worn only during the warm-up period. During competition, dogs shall wear no collars of any kind.

**DISCIPLINARY PROCEDURES:**

Any handler who is found to abuse a dog in any way at any AAC sanctioned event will be required to leave the site. In an incident of abuse or dog aggression, toward another dog or person, occurs, the incident MUST be reported to the Judge or Trial officials. Anyone witnessing an act of abuse or aggression may make a complaint to the host club and or AAC.

**AGILITY OBSTACLES:** Obstacles shall be chosen from those described in the current edition of the Official Rules and Regulations of the Agility Association of Canada.

**PRIZES AND AWARDS:**

Placement ribbons from 1<sup>st</sup> to 4<sup>th</sup> / Rosettes for all qualifying scores.

**Volunteer Prizes:** All competitors who volunteer will be entered for prize draws each day.
